- Q1. What method of installation will be used? Is it open cut or will there be any boring involve? Jack and Bore or Directional Bore?**

A1. Installation of the water main shall be mostly done by open-cut method. All concrete and/ or Asphalt driveways are to be free-bored unless noted otherwise in the bid drawings.

- Q2. What are the approximate lengths and diameters of the portions to be bored?**

A2. Refer to bid drawings for lengths and diameters of the portions to be free-bored.

- Q3. What is the cost estimate for this project?**

A3. There is approved funding for this project. Gwinnett County expects each contractor to bid a competitive price. The award will be made to the lowest responsive and responsible bidder.
