**CALL FOR SPECIAL ELECTION**

**TO THE QUALIFIED VOTERS OF GWINNETT COUNTY:**

Pursuant to Senate Bill 333, signed by the Governor on February 13, 2024, in the 2023-2024 Regular Session of the Georgia General Assembly, the Gwinnett County Board of Registrations and Elections (hereinafter known as the "Board"), as Elections Superintendent for Gwinnett County, is charged with the duty of calling for a Special Election to be held on May 21, 2024.

Therefore, the Board hereby issues the call for said Special Election to be held on May 21, 2024. The purpose of said Special Election is to place before the voters of Gwinnett County that reside within the proposed corporate limits of the City of Mulberry as described in Appendix A of the Charter, for approval or rejection, the question stated in SB 333 concerning whether or not the Act incorporating the City of Mulberry in Gwinnett County according to the charter contained in the Act shall be approved as provided in Section 11 of the Act, to-wit:

- YES    Shall the Act incorporating the City  
 NO       of Mulberry in Gwinnett County according  
                 to the charter contained in the Act be  
                 approved?

All persons desiring to vote for approval of the Act shall vote "Yes", and all persons desiring to vote for rejection of the Act shall vote "No". If more than one-half of the votes cast on the question are for approval of the Act, it shall become of full force and effect upon the certification of the results of the referendum election, otherwise it shall be void and of no force and effect.

The Special Election shall be conducted in the precincts of Gwinnett County that fall within the proposed corporate limits of the City of Mulberry as described in Appendix A of the Charter. The polls will open at 7:00 o'clock A.M. and close at 7:00 o'clock P.M. The last day for qualified residents of Gwinnett County to register to vote to be eligible to vote in the Special Election is April 22, 2024.

This call is issued and published pursuant to Official Code of Georgia Annotated Sections 21-2-2(3) and 21-2-540 and SB 333.
